Treasurer's Report: Deborah Covington, Ops. Mgr., presented the financial reports. Reports were sent out to Board members and questions asked. The questions were answered via email.

Senior Minister's Report: Rev. Dr. Sherry F. McCreary

The SBA Economic Injury Disaster Loan (EIDL) was applied for and approved for \$122,700. SBA will have a security interest in all CLF personal property, not real property. The installment payments (including

principal and interest) will be \$524.00 per month beginning 12 months from the date of the promissory note (7/22/2020). Balance of principal and interest payable 30 years from the date of the promissory note. The interest is 2.75% per annum.

The Mortgage Loan Deferral period at Comerica Bank ends on July 31. August 3 is the due date for payment of the accrued interest plus the August principal and interest payment, in the amount of \$20,001.67

Rev. Sherry reported that she had been in communication with the Anita Turk, at Comerica Bank requesting a 30-day extension per the contract. Anita said that wasn't an option, then proposed a 90-day extension but wanted it to include conditions. After discussion, the Board determined this was not a viable option and voted to make the loan deferral payment.

\$25,000 of the \$40,000 that had been on hold at Comerica was transferred from Comerica to the CLF Bank of America account.

Discussion regarding the property.

Rev. Sherry will send out a communication to the congregation to update Sunday service plans.

There was discussion regarding posting the financials on the website to include Income & Expenses & the difference.

The idea of a Pandemic Payoff Pledge Drive was presented and discussed. The drive will last until the end of September.

Rev. Sherry reported that Dr. Bobbie is now the Board Practitioner. She will offer Opening and Closing Prayer for BOT Meetings, and will be available for prayer during meetings, if necessary. She will also be available for prayer with individual BOT members.
